Minister's Minute

I'm sure we were all disappointed that the council chose to postpone our 50th Anniversary Celebration until September 17. Unfortunately COVID cases had a sudden peak in June which took aim at the council as half of the council either had symptoms or were in quarantine due to possible exposure. Start praying now that COVID B4 & B5 cases will suddenly drop in September.

This month our fraternity meeting will have three guests if things go according to plan. Sarah Ryan from the Lighthouse shelter in Annapolis will speak about the work that is done there and the support our fraternity has been providing in the form of both sandwiches once a month and all-day bus passes quarterly.

Our other two visitors will be from the region: Bob Longo, the regional minister and Mary Badjo, the regional councilor for Maryland. They will be making their regional visitation. Our Constitution states:

Article 92 Rule 26. The purpose of both the pastoral and fraternal visits is to revive the evangelical Franciscan spirit, to assure fidelity to the charism and to the Rule, to offer help to fraternity life, to reinforce the bond of the unity of the Order, and to promote its most effective insertion into the Franciscan family and the Church.

Article 94 – The Fraternal Visit

1. The fraternal visit is a moment of communion, an expression of the service and concrete interest of the secular leaders at the various levels, so that the fraternity may grow and be faithful to its vocation.

2. Among the various initiatives to achieve the purpose of the visit, the visitor will give special attention: -- to the validity of the formation, both initial and permanent; -- to the relations entertained with other fraternities at the different levels, with Franciscan youth, and with the entire Franciscan family. -- to the observance of the directives and of the guidelines of the International Council of the SFO and of the other councils; -- to the presence in the local Church.

3. The visitor will check the report of the previous audit or verification of the financial and property management of the Council, the register of the accounts and every document pertaining to the property of the fraternity and, if applicable, the condition of the juridical personality in the civil order, including the fiscal aspects. In absence of the required audit of the financial and property management of the council, the visitor can commission such an audit, to be paid by the visited fraternity, to an expert who is not a member of the council concerned. Wherever he or she deems it opportune, the visitor will obtain the assistance of a competent person in these aspects.

4. The visitor will check the records of the election of the council. He or she will evaluate the quality of the service offered to the fraternity by the minister and by the other leaders and will study with them the solution to problems which may arise.

If, for whatever reason, he or she should find that their service does not meet the needs of the fraternity, the visitor will promote appropriate initiatives, taking into account also the provisions concerning resignation and removal from office, given special circumstances .

5. The visitor may not carry out the visit of his or her own local fraternity, nor of the council of another level of which he or she is a member.

Unfortunately we will not have our pastoral visit until a later date. We had hoped to have both the fraternal and pastoral visits at the same time.

In practical terms, it means the council will meet with the regional visitors after they have observed our fraternity meeting. So if the council members look a bit rushed in the cleanup or disappear to the other room leaving you to handle the cleanup, please realize that we will be reviewing the fraternity records with the visitors for the next hour or more after the meeting. Due to COVID we are actually 22 months overdue for our visit.... So the visitors might look a bit frazzled as well since they are trying to catch up on a lot of overdue visits.

Update on St. John the Evangelist Church Renovations

Here are the parts of the plan that apply to us:

New Parish Offices

The renovation of the former convent is nearing completion and all the parish offices will move into the new space this July. The new space will host all the parish offices in one location, plus provide meeting space for <u>parish</u> groups and ministries.

New Kindergarten Classrooms

The former Faith Formation offices, located in the school, will be converted into new kindergarten classrooms for our school this summer. The new classrooms will be ready for the upcoming 2022-2023 school year. [Yes, this is the Youth Room where we previously met.]

New Adult Meeting Space

The modular unit that has served as two of our kindergarten classes will be used for adult meeting space once the kindergarten classes have moved into the school. This will provide the parish with two additional medium-size meeting areas. [This is probably where we will be meeting.]

So it appears that we would be meeting in the trailer near the old convent. With luck we may be back to our old location by October. I am concerned that the space may be smaller.
